### *Statement of Peace*

**I testify to the following:**

- I will only pursue peaceful solutions to the violence of abortion when volunteering with the 40 Days for Life campaign.
- I will show compassion and reflect Christ's love to all abortion facility employees, volunteers, and customers.
- I understand that acting in a violent or harmful manner immediately and completely disassociates me from the 40 Days for Life campaign.
- I am in no way associated with Delta Clinic, any abortion facility or its affiliates by way of employment, informant, volunteer, client, or otherwise.

**While in front of the Delta Clinic abortion facility:**

- I will keep moving at all times, and will be careful to **yield to cars and pedestrians entering the parking lot.**
- **I will not obstruct the driveway, sidewalk or doorways.**
- **I will not physically touch anyone, even in a friendly way.**
- **I will not threaten or verbally abuse anyone.**
- **I will not trespass on the private property of the Delta Clinic**, which includes the parking lot or throwing anything into the abortion facility's garbage cans.
- I will not litter on the public right of way.
- I will closely attend to any children I bring to the prayer vigil.
- I will not vandalize private or public property.
- I will park in the areas that 40 DFL BR has been given permission.
- I will cooperate with local city authorities.

### *Participant Waiver of Liability*

I understand that BR-RTL and the Diocese have not inspected the property nor does BR-RTL and the Diocese take any responsibility for the upkeep or maintenance of the property. Said property may contain defects that could cause bodily harm such as but not limited to cracks in the sidewalk or holes in the ground that could cause injury.

I fully understand the risks and assume the responsibility for those risks described above.

I understand that the clauses of this waiver are severable and not joint. Should any clause be found null in a court of law, that provision will be considered severed and the remainder of the waiver shall be considered valid and binding.
